I understand that this application is in no way a guarantee of a free trip. The parties responsible for the event are required to contact the Dayton to Daytona Trip Coordinators with a follow-up description of the event no more than 72 hours post-event for the purpose of the Dayton to Daytona Committee records. The trip is awarded to the above listed organization *on the condition that the follow-up takes place*. I understand that if I fail to submit a follow up of my event, and have been awarded permission to give/raffle a free trip, my organization's free trip is revoked and the applicant must pay the standard amount for their trip. I understand that the involvement of the event participants cannot be intended for the sole purpose of obtaining a free trip.

I understand that trips are awarded on a very selective basis due to high demand for free/raffled/discounted trips, and the committee strives to award trips on a fair and equal basis to the organization that exemplifies the ideals most coherent with those of the University and of the Dayton to Daytona Committee. If the recipient of the free trip certification is awarded more than one free trip, they have the right to "donate" the extra trip(s) to the student or organization of their choice. I understand that only current students of the University of Dayton undergraduate program can receive a free trip.
